Dear Parent/Carer,

As you will be aware Mark Drakeford, First Minister, has announced today that significantly enhanced restriction measures will be implemented in Wales from 6pm on Friday the 23<sup>rd</sup> of October until midnight on the 9<sup>th</sup> of November. These measures will include the half-term holiday and cover a two-week period, ending on Monday the 9<sup>th</sup> of November. These restrictions, or fire-break, is intended to help to bring the Covid-19 virus under control in an attempt to reduce the number of people being taken to hospital with coronavirus symptoms and to minimise pressures on our health and social care staff.

Between Friday the 23<sup>rd</sup> of October and Monday the 9<sup>th</sup> of November, everyone in Wales will be required to stay at home. This means working from home wherever possible. The only exceptions to this requirement will be for critical workers and for those individuals who cannot work from home. All non-essential retail, leisure, hospitality, tourism businesses, community centres, libraries and recycling centres will close. Keeping children safe remains the highest priority for the Council and for Welsh Government and with this in mind:

- Childcare facilities will stay open;
- Primary schools, special schools, pupil referral units and Education Otherwise that at School (EOTAS) provision will re-open as normal after the half-term break;
- Secondary schools will re-open after the half-term for years seven and eight only;
- For all pupils sitting exams in November, they will attend school for examinations only;
- For learners in years nine to thirteen, education will be provided through distance learning in the home. This will require your child to access learning opportunities remotely, through digital means using ICT or through work packs sent to your home. It is vitally important that you and your child routinely check school communication channels and platforms to establish what work and learning your child is required to engage in.

Welsh Government will be issuing guidance for schools for this period shortly which will include minimum expectations for learning. This will include teachers delivering online lessons from the classroom to your home.

Free school meal arrangements will be put in place over half-term for all learners who are eligible and this will be paid via BACS payment. This payment will be put in place for pupils in years nine, ten, eleven, twelve and thirteen for the second week when the restrictions are in place.

Restricting the numbers of pupils in schools will contribute to the wider national effort aimed at reducing the spread of Covid-19. The relatively small number of confirmed cases of Covid-19 in our schools, suggests that schools have good infection control measures in place for keeping learners and staff safe. The priority as always is to keep everyone safe and to minimise any disruption to learning during this period. School transport will continue to run as normal and all previously issued guidance remains relevant.
